Dear St. Johns County Parents,

Welcome back to school! We are excited for the year ahead and have a few updates for this school year that we wanted to share with you.

First, the St. Johns County Sheriff's Office (SJSO) has created a Youth Services Threat Assessment Team. The team consists of members from the St. Johns County Sheriff's Office, the FBI, and the St. Johns County School District. The team will meet consistently throughout the year and review every SJSO Juvenile Threat Assessment that has been conducted to determine proper classification, possible criminal elements, if any assistance is needed for family, and determine if the School District's Threat Assessment coincides with SJSO.

Second, the creation of this team will include the addition of two Threat Assessment Deputies. They will be responsible for conducting investigations into credible threats that are made against St. Johns County Schools, students, and school staff. The Threat Assessment Deputies will also be responsible for follow-up investigations into runaway juveniles, general crime investigations regarding St. Johns County Schools, and other juvenile criminal investigations. This position will also serve as a liaison between the St. Johns County Sheriff's Office Threat Assessment Team and the St. Johns County School District.

Our last major update for this school year is the implementation of body worn cameras on our Youth Resource Deputies. These cameras will only be utilized when a deputy is requested to provide law enforcement action for a violation of a crime as defined in Florida State Statutes.

I remain steadfast in my challenge to all parents to continue being an active participant in your child's life. Their future depends on it. I would also encourage you and your child to utilize the FortifyFL app to report suspicious information that is learned by our schools and students. These tips are relayed to law enforcement and school officials for immediate investigation. It is incredibly important for parents to remain vigilant and aware of their children's activities at school and elsewhere.

I also challenge both parents and students to get to know your respective school's Youth Resource Deputy. The St. Johns County Sheriff's Office Youth Resource Deputies are there for each of you. If you hear or see something you think isn't right or you have a question about, reach out to them. It is vital that our students know that the deputy in a uniform is a friend and there to be a resource to them.

Finally, this is a community partnership. I'd like to thank you for your continued support of law enforcement in St. Johns County. It is truly our honor to be of service to you. As always, please do not hesitate to contact my office if we can ever be of assistance.

ROBLOX IS AN ONLINE GAMING PLATFORM WITH A CHAT FUNCTION. UNDERAGE USERS HAVE HAD ISSUES WITH SOLICITATION FROM SEXUAL PREDATORS.

TIKTOK IS A MOBILE DEVICE APP POPULAR WITH KIDS USED FOR CREATING AND SHARING SHORT VIDEOS. WITH VERY LIMITED PRIVACY CONTROLS, USERS ARE VERY VULNERABLE TO CYBER BULLYING AND EXPLICIT CONTENT.
